Grooming and bathing involve close contact, and while we strive to minimize stress, being in the facility can be overwhelming for pets. To ensure the safety of both pets and staff, if a pet becomes too anxious or stressed during grooming, we reserve the right to stop and reassess. This may include taking a break in their kennel, muzzling, adding a handler (with an additional fee), or stopping the grooming session. Please note that puppies may find grooming more challenging, and older pets may have difficulty standing or staying still for long periods.

Matts and Deshedding - Grooming

Matting is a tight knot that extends to the skin and can conceal un-	iderlying sk	in conditi	ions. I und	lerstand
that if my pet is heavily matted, and is shaved down it could reveal cond	litions such	as rashes	or infection	ons that
may need medical attention.				

Depending on the severity of the matting, the groomer may contact you to discuss whether a shave-down or a dematting brush-out is necessary. I understand there are cost differences between these options. If your pet is able to be dematted. Dematting fees will apply to cover the additional time required. Fees may range from.

_____Deshedding is necessary when a pet's coat is compacted, requiring multiple baths, force drying, and additional brushing to thoroughly clean and protect the coat. Pets with double coats require deshedding for a proper grooming cut. Deshedding fees range from and will be applied to the price of your groom..
